### Background

In the 1960s there was, throughout the Fire Service, a strong feeling for the need to secure a positive channel of communication to enable high-level representation to be made on the behalf of Fire Service Pensioners, their widows and dependants.

The need for a national association became particularly urgent when the Government of the time published proposals to interfere with the earned and paid for pensions of public servants by removing or reducing their pension entitlements.

This urgency resulted in a meeting at the Fire Service College, Moreton-in-Marsh, in 1968, where representatives of sixty former Fire Brigades formed the National Association of Fire Brigade Pensioners.

Since then the Pensioners' Association has been re-named, and today it consists of a National Council, Districts Councils and Branches, covering the whole of the United Kingdom. Each district consists of a number of branches. Both branches and districts have their own officials: Chairman, Secretary and Treasurer.

Those who for various reasons choose not to join a branch may join directly as Direct Members by contacting the NARF Office at Erdington, tel. 0121 380 6059. This office is manned by volunteers Monday to Friday (except Bank Holidays) between the hours of 10.00am and 2.00pm. Outside these hours, or if there is no reply, the answer phone will give you an emergency number.

The management of the Association is vested, by the constitution, in the council, which consists of national officers, and a representative from each district.

### South Yorkshire

South Yorkshire is part of No.3 District, and is divided into two branches: Barnsley and Doncaster Branch, and Sheffield and Rotherham Branch.

### Subscriptions

Subscriptions are used to assist in maintaining the branches, and a percentage is paid to the National Association to defray the expenses of employing QCs, representatives in Parliament, and attendance at pension related meetings/inquiries.

The subscriptions are currently £6.00 per annum (£0.50 pence per month), and are deducted on a monthly basis from your pension by the Payroll Section of South Yorkshire Fire and Rescue.
